Whereas Late Shree Fakirbhai Pansare Education Foundation's College of Physiotherapy (BPTH) established in the year 2008 duly recognized by Maharashtra State OTPT Council, Mumbai and affiliated to Maharashtra University of Health Sciences, Nashik and approved by Government of Maharashtra vide G.R No. PSO-1307/PR.NO.27/07/Education-1, dated 14/09/2007 And chairman of Late Shree Fakirbhai Pansare Education Foundation's having powers to enter into agreement for affording practical training of students of the college of Physiotherapy (BPTH) at Yashwantrao Chavan Memorial Hospital (YCMH) Under Pimpri Chinchwad municipal corporation.

Whereas the corporation there upon in its standing Committee Meeting passed resolution No-798 dated 17/07/2012 allowing Late Shree Fakirbhai Pansare Education Foundation college of Physiotherapy to use Yashwantrao Chavan Memorial Hospital and Pimpri Chinchwad Municipal Corporation all Hospital for practical training for its students of Physiotherapy (BPTH)

Now therefore following terms and conditions have been prescribed and those have been accepted by both the parties:

1. Late Shree Fakirbhai Pansare Education Foundation college of Physiotherapy (BPTH) will pay Rs. 10,000/- deposit towards (refundable) for YCM Hospital of Corporation for granting permission to BPTH course.
2. The corporation hereby allows Late Shree Fakirbhai Pansare Education Foundation college of Physiotherapy (BPTH) to make use of Yashwantrao Chavan Memorial Hospital, to impart practical training to its Physiotherapy (BPTH) Students.
3. **IIIrd year to Internship Year-25 students**
4. The corporation will not pay any remuneration to Late Shree Fakirbhai Pansare Education Foundation college of Physiotherapy (BPTH) students on this account.
5. Late Shree Fakirbhai Pansare Education Foundation college of Physiotherapy (BPTH) will not claim any type of fund or grant from the corporation for this educational activity.
6. In consideration for the facility of practical training made available. Late Shree Fakirbhai Pansare Education Foundation college of Physiotherapy (BPTH) will pay the remuneration to the corporation.
7. Remuneration will be paid as per the rate prescribed by the Govt. of Maharashtra per day per bed Rs.15/- for each student.
8. The clinical instructors/ clinical Tutor will do the day today supervision during posting in concern hospital.
9. Late Shree Fakirbhai Pansare Education Foundation college of Physiotherapy (BPTH) will insure that the students will maintain discipline during the tenure of training in the hospital.
10. Late Shree Fakirbhai Pansare Education Foundation college of Physiotherapy (BPTH) has to ensure that the students attending the hospital regularly and in time for the duty hours.
11. This agreement is valid for a period of **01st Jan 2020 to 31st Dec. 2024**. the date of this agreement and renewable every five consecutive years as per the resolution of standing committee.
12. Late Shree Fakirbhai Pansare Education Foundation college of Physiotherapy (BPTH) will be responsible for all the claims, correspondence or (BPTH) will be responsible for all the claims, correspondence or expenses payable to consequences of any accident or injuries sustained by any student in the hospital.
